# Industry Excellence Award 2018

## ${f A}$ bout The Institution of Engineers (India) =

The Institution of Engineers (India) is the largest multi-disciplinary professional body of engineers with 15 engineering disciplines and over 8,00,000 members in India and abroad. The Institution was established in 1920 and was incorporated by Royal Charter in 1935. In order to provide special attention to some of the important national issues, in addition to engineering disciplines, it has established special vehicles of focus. Engineering Staff College of India (ESCI), National Design & Research Forum (NDRF), Rural Development Forum (RDF), Safety & Quality Forum (SQF), Sustainable Development Forum (SDF) and Water Management Forum (WMF) are six such focused initiatives. The Institution is a widely admired name in international arena in the field of engineering and technology besides being a founder member of World Federation of Engineering Organizations (WFEO), Federation of Engineering Institutions of South & Central Asia (FEISCA) and Commonwealth Engineers' Council (CEC). With its large international linkages and a network of 121 Centres in India and 6 Overseas Chapters, the Institution has built up wide reach and large infrastructure to meet its objectives of promoting engineering in all aspects. The IEI is now authorized to operate Indian Section of the International Professional Engineers (IntPE) Register. The eligible Indian Professional Engineers would be placed, after due process, on the International Register. They would be entitled to exclusively use the title IntPE(India), indicating their international status. All eligible Indian engineers can now apply for Professional Engineers (PE) Certification through IEI only.

## $\mathbf{P}_{reamble_{=}}$

The IEI Industry Excellence Award has been instituted to recognize industry leaders for their innovation, excellence in engineering operations and services and their capacity to sustain excellence in a competitive manner. The bench-marks created by the industries in India have included productivity, quality, safety and performance assurance which would give India the rightful place in the global markets.

Realizing that such industries can provide encouragement to a large number of other industries in the country, it has been considered appropriate by the IEI Council to launch the IEI Industry Excellence Award in the year 2008.

Since its inception in 2008, industries like SAIL, Indian Oil Corporation, Tata Motors Ltd., Electronic Corporation of India Limited, Kirloskar Brothers Ltd., Larsen & Toubro Ltd., Bharat Electronics Ltd., CESC Ltd., Neyveli Lignite Corporation Ltd, Bharat Heavy Electricals Ltd., Tata Steels Ltd., NTPC, HAL, Bharat Forge Limited, BrahMos Aerospace Private Limited, Rajasthan Electronics & Instruments Ltd, NBCC (India) Limited, MECON Limited and M N Dastur & Company (P) Ltd., etc. had been the rightful winners of the above Award. Further, the 'Certificate of Appreciation' / 'Certificate of Commendation' had been presented to organisations like J K Tyre & Industries Ltd, Hindustan Zinc Limited, Power Grid Corporation of India Ltd. and Deepak Fertilizers & Petrochemicals Corporation Ltd, Precast India Infrastructures Private Limited etc.

# ${f M}$ odalities for the Award \_

The Award is 'application based' and every engineering industry working in the country is welcome to participate. The application has to be sent as per the enclosed format, which can also be downloaded from the website of IEI (www.ieindia.org), along with the requisite application fee. The application is to be submitted in 5 hard copies along with a soft copy in a CD. Awards will be given to industry/industries selected on the basis of assessment report of the Committee and the recommendations of the Jury which is the second level and the final decision making body.

#### Categories of Awards.

The Awards would be given to the organisations engaged in engineering manufacturing as well as engineering services & consultancy under the following categories:

#### (a) Engineering Manufacturing & Processing

Category A: Organisations having turnover of Rs. 5000 cr. and above

Category B: Organisations having turnover of Rs. 1000 cr. and above but below Rs. 5000 cr.

Category C: Organisations having turnover of Rs. 500 cr. and above but below Rs. 1000 cr.

Category D: Organisations having turnover of Rs. 100 cr. and above but below Rs. 500 cr.

Category E: Organisations having turnover below Rs.100 cr.

#### (b) Engineering Services and Consultancy

Category A: Organisations having turnover of Rs.500 cr. and above

Category B: Organisations having turnover of Rs.100 cr. and above but below Rs.500 cr.

Category C: Organisations having turnover of Rs. 25 cr. and above but below Rs100 cr.

Category D: Organisations having turnover below Rs. 25 cr.

Note: Turnover bracket for each category represents the turnover amount required to be achieved by the applicant in any one FY amongst the last three FYs.

#### $\mathbf W$ hat do you Gain by Applying for the Award ? =

The proforma, having self-assessment procedure, will give the applicant organisation an opportunity to identify its strength & weakness and its standing through the process of applying for this Award. The proforma is based on international standards and is prepared by experts to collect information and assess performance of the applicant industries.

# ${f W}$ hat will Jury look for ? $\_$

The Jury for the selection will look for the procedure being followed by the industry and their bench marking. The Jury will also look into the innovative approaches that the industry has been involved in and the improvement in performance of the industry. The Jury will also be interested in finding out the thrust of the corporate governance and corporate social responsibility strategies and other innovative approaches, improving competitiveness for the greater benefit of the society and the country.

#### A ssessment Process -

The assessment of the applications will be carried out at two levels as follows:

- The first level of assessment would be carried out based on the weightage given to different items in the application proforma. The shortlisted ••• applications will then be selected and presented to the Jury.
- The second and final level assessment would be carried out by the Jury Board. ٠

The decision of the Jury would be communicated to the selected Award winners. The decision of the Jury shall be final and binding.


